February 3, 2025

REGULAR BOARD MEETING

- 1. Board President Alma Garcia called the meeting to order at 4:00 pm.
- **2. Roll Call:** Those in attendance were Alma Garcia, Allana Essary, Cynthia Mortenson, Angel Vasquez, Daniel Boss, Edgar Garcia, Kirk Waddle, Justin Price, Shawna Hill, Janet Pursley, and Zaida Coronado.
- **3. Agenda Adoption:** Angel Vasquez motioned to approve the agenda with the modification of Policy Advisories 801-808 instead of 801-807. Cynthia Mortenson seconded the motion and the motion passed 5-0.
- **4. Approval of Minutes:** Cynthia Mortenson motioned to approve the minutes from January 2025 as presented. Daniel Boss seconded the motion and the motion passed 5-0.
- 5. Superintendents Report: Edgar Garcia provides an update on testing, mentioning that juniors and seniors completed testing last week, and benchmark testing for English and math has started. He highlights the role of Karla Armenta, the new testing coordinator, in organizing all testing schedules. He discusses the unification update, explaining the potential tax implications for different districts if they join the new unification district. He mentions that Kirk, the business manager consultant, is assisting with budgeting and training to better handle financial matters. Edgar provides an update on the Office of Civil Rights Complaint, stating that no fault has been found on either side, and mediation is ongoing. Shawna Hill provides a sports update, mentioning upcoming events and the transition to an online platform for physicals

and eligibility checks. Justin Price discusses upcoming visits to colleges and the effectiveness of FAFSA night, which had a good turnout despite low attendance. Davida Noble also discussed the success of regional competitions and the upcoming state competition.
